# Chairperson's Report

for the shareholders of New Zealand Catholic Education Office Limited for the year ended 31 December 2017



It is with pleasure that I report to the shareholders on the work of NZCEO during 2017.

2017 will be remembered as a significant year in the history of integrated schools. It marks the first major review of the Private Schools Conditional Integration Act (1975). The Act was updated and subsumed into the Education Act (1989) during this parliamentary year. Detailed work with the Ministry of Education (MOE) protected the strengths of the original Act.

The Office maintained relationships with Ministers of Education Hekia Parata and Nikki Kaye during the year and worked closely with them to effect a settlement of the Quantity Funding claim that had been before government for sixteen years. The 2017 Parliamentary Budget granted \$20 million, to be delivered over two years. Much work has gone into reaching a settlement with the Crown. Proprietors were consulted a number of times during the course of the negotiations. The settlement brings this historical issue to a close, and allows us to plan and direct resources to retiring debt and supporting Proprietors to focus on planning to bring their schools up to the School Property Guide recommendations.

NZCEO continues to work closely with MOE staff to monitor Policy One grants to schools. In late 2017 the MOE announced the largest single increase in the grant since its inception, with a 13.8% increase to \$765.85 per student (incl. gst) for 2018. Proprietors rely on Policy One funding for the maintenance of their property, but during 2017 we saw some Proprietors challenged by the cost of earthquake remediation for which their total Policy

One entitlement was insufficient. Discussions are taking place with government to help support these Proprietors, and NZCEO will initiate discussion about protecting our network and having further provision for unexpected major works as part of its policy development in 2018.

In addition to the Quantity Funding Settlements, in 2017 NZCEO consulted Proprietors about the release of a further \$20 million for debt servicing from the National Debt Servicing Scheme. In a collaborative way, all Proprietors supported the recommendations that went to the Board. These recommendations have since been confirmed by the Board. During 2018 and 2019 NZCEO will work with the New Zealand Catholic Bishop's Conference (NZCBC) and Proprietors to see that the current priorities for funding remain fit for purpose.

In 2016 we noted that some shareholders had indicated that they were considering withdrawing from the Shareholders' Master Agreement. I am pleased to report that all shareholders have retained their participation in the Master Agreement. We look forward to continuing to serve you all.

NZCEO has reported to NZCBC on three occasions and met with NZCBC Finance twice. NZCBC has renewed its Mandate to NZCEO and asked that during 2018 we conduct a review of the financial model, using the Mandate as a guide to the principles upon which we operate the attendance dues scheme. The Board is establishing the parameters for a review to take place during 2018.

In 2017 we developed a Strategic Plan which summarised in diagrammatic form the key areas of work for the Office. In the next section of this report you will see the Office's report on NZCEO's progress on this plan during 2017.

NZCEO produced some new data during 2017, which is designed to assist Proprietors to manage their networks and understand changes in demography. We know that from 2018 we will come under more pressure from MOE to review the viability and sustainability of our networks, as population grows in some areas and declines in others.

During 2017 the CEO and his managers worked to integrate technology in the way we communicate, by

introducing video conferencing. Once the challenges of software were ironed out, the Board has seen the ability of the Office to communicate more frequently and in a more timely way with Proprietors. We support this growth.

Other work that has been significant for the Office has been the close working relationships developed with The Catholic Institute (TCI) and the Catholic Enquiry Centre (CEC). Both relationships focus on evangelisation and the provision of formation to teachers in our schools. The Board supports the further development of this work.

The document *The National Framework for Catholic Character Review for Development* has been reshaped, in a process which took several years. The NZCBC has now given permission for the document to be used in all dioceses. Already, the reviewers who have trialled it report that it enables more effective reviewing of Catholic schools.

NZCEO also became aware of the critical need to encourage young people into teaching in our schools, and has developed a very flexible and effective campaign to provide schools with resources and videos designed to promote teaching in our schools as a calling. The Office also participated in the National Catholic Youth Festival and it looks forward to hosting national retreats for teachers in 2018.

Our Catholic schools continue to gain recognition. Success in public examinations in Catholic secondary schools confirms the commitment to excellence. Schools continue to win accolades in sport, culture and pastoral care. There is much to be proud of in our schools and in the work being done as we continue on our journey of excellence.

A new school, Holy Trinity Catholic School in Takanini, was opened by the Auckland Diocese in 2017 and is already looking to expand. Another new Catholic primary school in Papamoa is being considered by government for funding in 2019.

The primary mission of our schools is to provide an encounter with Christ. Evidence from our Catholic Character reviewers across New Zealand confirms and affirms the work being done to make that happen. Our thanks to Proprietors, boards and teachers who play such a role in evangelising and catechising our young Catholic people.

As Chairperson I extend my sincere gratitude to my fellow Board members and to Paul Ferris and his team. Together they bring wide experience and expertise to their roles to ensure our nation's Catholic schools deliver the authentic, quality education which our Bishops, other Proprietors and the Church community legitimately expect.

# **CEO's Report**

## Introduction

This report covers the work that was the focus for our Strategic Plan in 2017. While some of this work is specifically related to Catholic schools, it is important to note that NZCEO has responsibility with government for the Association of Proprietors of Integrated Schools (APIS), and much work is done for the whole integrated schools sector. This is important to our mission.

## **Evangelisation**

# Supporting schools, students, families and parishes

In line with the requirements of NZCBC, the Office has increased its promotion of the need for evangelisation and for strengthening school/parish relationships, through commentary in publications, presentations and writing by the CEO, and in the Framework for Catholic Character review.

In support of youth evangelisation, the Office sponsored two diocesan Youth Ministers to travel to Australia to assess the Catholic Schools Youth Ministry (CSYMA) training programme, and also five teachers to Canberra in September to assess the appropriateness of the CSYMA programme for their schools. It is clear that there will be possibilities for the use of this model in New Zealand, but it will need to be shaped to New Zealand requirements. This work will continue in 2018.

The Office gave major support to the Aotearoa Catholic Youth Festival, which had a strong evangelisation component. During the festival Office staff promoted teaching in Catholic schools.



Churches Education Commission material for schools has been further developed, and new sets of cards were designed and distributed to schools. NZCEO continues to publicise and promote this evangelisation initiative to schools.



Planning for the **2018 Catholic Education Convention** continued.
Three major international keynotes were confirmed



We continued our support of the important work of **NCRS** and **Caritas** 

The Catholic Character Review for Development Framework has been rewritten in line with NZCBC's document, *The Catholic Education of School-Age Children*. It contains an increased emphasis on promoting formation and evangelisation for those in Catholic



schools. After trials in two dioceses it received NZCBC approval to be used in all dioceses and has been shared with the sector. Reviewers have received training in using the document and feedback so far has been unanimously positive. Implementing and improving the framework will continue each year.

Planning and preparations for the 2018 Catholic Education Convention continued during the year.

Frequent meetings occur with the staff of the National Centre for Religious Studies (NCRS), with joint planning and resourcing on some initiatives.

The Office supports and promotes the work of Caritas, the national Catholic aid agency, particularly in regard to their school programmes.



# Leadership

## Supporting governance and school leadership to continually enhance Catholic Character

The Office has engaged with the New Zealand School Trustees Association (NZSTA) to prepare and critique training sessions for Board of Trustees members in integrated schools. Changes in legislation delayed the implementation of these sessions.



Planning for improved electronic access to the *Handbook for Boards of Trustees of Catholic Schools* is underway. The handbook has undergone editing to update references to the Private Schools Conditional Integration Act with references to part 33 of the Education Act, as updated in 2017.

New and updated templates for letters offering employment in Catholic schools have been developed, with the assistance of New Zealand School Trustees Association (NZSTA). They are available on the NZCEO website.

New websites for NZCEO and APIS were launched. They have significantly improved design and access capability and improved branding and structure of information. The websites

will be monitored for use, and updated in response to use patterns.

## **Formation**

Identifying and supporting formation of leaders and teachers in our schools



The Office negotiated new or refreshed relationships with Toshiba, Alsco, OfficeMax, Noel Leeming and Furnware. Proceeds from these sponsorships are supporting the formation of teachers, through scholarships and through the 2018 Convention.

A survey of current formation programmes and needs in each diocese was also undertaken. The Office collaborated with national principals' associations as well as diocesan offices on this survey.

An inaugural national retreat for teachers has been planned, to take place in 2018. Depending on interest, it is hoped that this will lead to further retreats.

Collaboration with NCRS has had a particular focus on certification

Ahead Associates completed a final course for senior school staff preparing to seek leadership positions. The Office is embarking on new initiatives including support and development for new principals via video conferencing.

NZCEO worked with The Catholic Institute (TCI) to support an ongoing supply of well-qualified, committed teachers for Catholic schools. A Teacher and Leadership Development Special Reserve Fund of \$136,000 has been established to continue this work. Initially, the Special Reserve fund is providing scholarships for teachers to undertake the ACU Graduate Diploma in Catholic Leadership through TCI. Thirteen students so far have received this support. It is expected that more scholarships will be awarded in the years ahead.

A set of promotional videos and posters has been commissioned, focusing on a career in Catholic schools. Post-production is under way, with the videos to be distributed to schools in 2018.

## **Partnership**

## Working constructively with our stakeholders and schools to represent them and inform them

A survey of stakeholders on our current communication strategies revealed high levels of satisfaction, and gave support for further development. A new communication plan has been made for 2018, which will see most paper communications replaced with electronic communications.

Communication with diocesan education staff, reviewers and other interested parties now includes a video conferencing option, which enables much more effective and speedy consultation and dissemination of ideas.

Frequent electronic communications have informed members of the Catholic education sector, including Proprietors, about information and changes they need to be aware of.

Five editions of *Lighting New Fires*, three editions of the early childhood newsletter, and two editions each of *Good News and the News* and *Aoraki* were published. These publications are all designed to circulate necessary information, to stimulate good practice, and to alert readers to the successes of students and staff in integrated schools. Five blogs by the CEO were posted.

A series of speakers were invited throughout the year to present on issues relevant to schools, including topics such as learning support, cyber bullying and changes at Oranga Tamariki – Ministry for Children. These were broadcast live via video conferencing and attended by trustees, school leaders and school staff.

## Engagement

# Working constructively with government and government agencies to advocate, represent and inform

Office leadership have had a number of meetings with the Minister of Education, other Ministers, the Opposition Spokesperson for Education, and parliamentarians, in order to advance their understanding of the views and needs of integrated school proprietors, and to support integrated schools.

After the formation of the new government, a briefing for the incoming Minister of Education was prepared and delivered

The Office has engaged with the Ministry of Education on plans for new schools in areas of high population growth, in particular, Drury (South Auckland) and Papamoa (Tauranga).

The Office utilised Ministry of Education and Statistics NZ data to inform the work we do with dioceses regarding network planning and when developing reports about the national network.

Work continued with the Ministry of Education on ensuring that the transition of the PSCI Act into the Education Act (Part 33) retained the rights and responsibilities of the PSCI Act, and that it maintains the relationship between the Crown and the Proprietors of Integrated Schools. All Integration Agreements have been updated to match the text of the the revised Act.

Policy One funding has been agreed with MOE at a significantly higher rate than in previous years, which will be of significant benefit to schools.

Office staff have spent considerable time on the administration of changes to Integration Agreements, including work on maximum roll increase applications, site plan updates, and similar matters. The Ministry of Education works with the Office in this area.

Continuing agenda items in regular meetings with Ministry of Education senior staff include breaches of maximum roll; declining rolls as a result of demographic shifts; schools' financial management and audit reports; distinguishing donations and attendance dues; school transport; planning for the triennial Catholic Education Convention; matters of relevance to APIS; and issues where schools need assistance.




The Office has worked with diocesan writers and Education Council personnel in the development of extensions to the Education Council's Standards, showing their specific application in Catholic schools.

Agreement has been reached with the Education Council for the development of

governmental support for preparation for teaching in Catholic schools. There has been particular emphasis on the need to ensure that theology papers are recognised as a suitable academic qualification for entry to secondary teacher training. The CEO has been included on the Education Council's Initial Teacher Training Advisory Council.

Regular meetings have been held with all education sector bodies, to ensure understanding and support for Catholic schooling, and to contribute to education in New Zealand.



### **Finances**

# Managing and aligning funding to support access to integrated schools and promote a common good approach

Proprietors have been supported in their funding needs through another \$20 million release of debt servicing funding. Earthquake strengthening remains a matter of concern for some Proprietors, with the Office assisting as far as possible.

Regular meetings with Ministry of Education personnel have enabled the Office to present the funding needs of Proprietors to the Ministry.

The achievement of a \$20 million historical settlement of the Quantity Funding issue, and the distribution of the first half of this Recognition Funding, has been a significant success.

In 2018 NZCEO will advocate with government for a permanent allocation of Policy Two funding.

Business continuity planning has continued and accordingly, the Office has made updates to the structure of information systems to ensure better disaster resiliency.

The NZCEO Board's Guidelines for Governing Practice underwent their triennial review.

With the retirement of Michael Shanahan as legal counsel, Frank McLaughlin of Chapman Tripp has taken on this role.

The reputation of Catholic schools in New Zealand continues to be excellent. This is due to the leadership and energetic efforts of many teachers and those who govern and lead schools. Proprietor administrative systems that support schools also function effectively.



## Notes to the Summary Consolidated Financial Statements

for the year ended 31 December 2017

These summary consolidated financial statements comprise the summary financial statements of New Zealand Catholic Education Office Limited (NZCEO) and its wholly-owned subsidiary NZCEO Finance Limited (NZCEO Finance) (together the 'Group').

These summary consolidated financial statements have been extracted from the full consolidated financial statements for the year ended 31 December 2017. The full consolidated financial statements for the year ended 31 December 2017 were authorised for issue by the Board on 18 April 2018. The full consolidated financial statements for the year ended 31 December 2017 have been audited and received an unqualified audit opinion.

The full consolidated financial statements for the year ended 31 December 2017 were prepared under Tier 2

PBE Standards RDR (NFP). These summary consolidated financial statements do not include all the disclosures provided in the full consolidated financial statements and cannot be expected to provide as complete an understanding as provided by the full consolidated financial statements. These summary consolidated financial statements comply with PBE Standards as they relate to summary financial statements.

The presentation currency is New Zealand dollars rounded to the nearest thousand dollars.

Copies of the full consolidated financial statements for the year ended 31 December 2017 are available on our website **www.nzceo.org.nz**.

## Recognition Funding payable

During the year, NZCEO, acting for the Association of Proprietors of Integrated Schools (APIS), reached an agreement with the Crown relating to historical Quantity Funding differences for state integrated school Proprietors. The agreement allows for Recognition Funding of \$20 million to be paid in two

# Notes to the Summary Consolidated Financial Statements continued



equal instalments over the Crown financial years of 2017/2018 and 2018/2019. Under the terms of the agreement NZCEO is to distribute the funding to the Proprietors of State integrated schools. \$10 million was received in 2017, of which \$3,101,406 was distributed to state integrated school proprietors other than those Proprietors who are members of the National Attendance Dues and Capital Indebtedness Sharing Scheme (the 'Scheme'). Included in the Recognition Funding payable is an amount of \$6,758,614 in relation to Proprietors who are members of the Scheme and hence, related parties. NZCEO is still working through discussions of how to distribute the remaining 2017 funding to the proprietors who are members of the Scheme.

### Related party transactions

NZCEO provides administration services to its whollyowned subsidiary NZCEO Finance, and to the Catholic Education Trust Fund and the National Attendance Dues and Capital Indebtedness Sharing Scheme on behalf of Participating Proprietors. During the year NZCEO Finance took out loans from the Catholic Education Trust Fund and on-lent that money to the National Attendance Dues and Capital Indebtedness Sharing Scheme to fund any shortfall between the national attendance dues received from Participating Proprietors and the debt servicing paid on behalf of the Participating Proprietors.

All administration costs for NZCEO Finance (2017 \$72,853; 2016 \$68,120), National Attendance Dues and Capital Indebtedness Scheme (2017 \$20,815; 2016 \$19,231) and the Catholic Education Trust Fund (2017 \$10,408; 2016 \$9,615) were initially paid by NZCEO and recovered by way of reimbursement.

Loans are provided by NZCEO Finance to Participating Proprietors of the National Attendance Dues and Capital Indebtedness Sharing Scheme. The Participating Proprietors of the Scheme are also shareholders of NZCEO.

Recognition Funding payable includes a balance of \$6,758,614 related to Participating Proprietors of the National Attendance Dues and Capital Indebtedness Sharing Scheme.
